

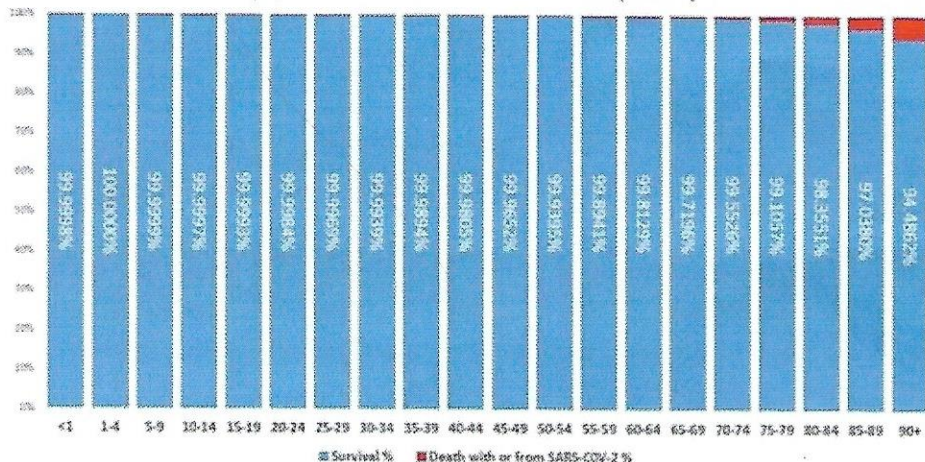

Fever), Hepatic disorders (inc. Thrombosis, Immune system disorders (inc. Anaphylaxis), Infections (inc. Nasopharyngitis), Injuries (inc. Contusion [blood vessels rupture]), Investigations, Metabolic disorders, Muscle & tissue disorders (inc. Bell's Palsy / Myalgia), Neoplasms, Nervous system disorders (inc. Seizure / Tremor / Guillain-Barre syndrome), Pregnancy conditions (inc. Spontaneous Abortion), Psychiatric disorders (inc. Nerve Injury / Confusion), Renal & urinary disorders, Reproductive & breast disorders (inc. Vaginal haemorrhage), Respiratory disorders, Skin disorders (inc. Rash), Social circumstances, Surgical & medical procedures, Vascular disorders (inc. Haemorrhage).
