



SCIENTIFIC Discovery. Science World quarterly announces the publication of the discovery of the means of energy transfer in electricity, made by physicists I. Catt, M. Davidson, and D.S. Walton. The old "free electron theory" is incapable explaining electricity flow in a radio transmission aerial, and electrons are in fact strongly bound against gravity. The authors sought to verify an alternative theory by taking a 1 metre long cable and giving it a charge of 10 volts. They then discharged the stored energy (via the closure of a high-speed electronic switch) into a sampling oscilloscope, and very carefully measured the discharge rate. They demonstrated a steady discharge over a time of 6.67 ns, which is twice the time taken by light to travel the distance of 1 metre. Dear Ivor Catt,
